TERMS AND CONDITIONS

1. Everything possible shall be done to ensure that the seedlings will be delivered on the pre-arranged date for delivery, but no undertaking whatsoever can be given in this regard. Should the delivery of seedlings be delayed for any reason, no liability for damage or loss occasioned thereby, can be accepted.
2. The applicant undertakes to take delivery of the seedlings within 7 (seven) days after the date on which Hishtil advise the applicant that the seedlings are ready. Should the seedlings not have been collected within this period or should suitable arrangements not have been made for the delivery thereof, the seedlings may be forfeited.
3. Orders shall only be confirmed once the applicant has paid the required deposit on the total purchase price, VAT included. The balance shall be paid before the applicant takes delivery at Hishtil's premises or in the event of delivery to the applicant at another place, before such delivery takes place. Should for any reason whatsoever, the total purchase price not be paid on date of delivery, then all outstanding amounts shall bear interest at the prime lending rate of First National Bank, Modjadjiskloof plus 3% (three percent).
4. All prices of the seedlings are subject to change without notice, unless the full purchase price is paid with the order. Advance orders are subject to the existing prices at the date of delivery.
5. Notwithstanding the origin of the seed thereof, all seedlings shall remain the property of Hishtil until the full purchase price has been paid.
6. The applicant confirms that all persons placing orders at Hishtil are authorised to place such orders and to take delivery of the seedlings and that these persons are authorised to make contact with Hishtil for these purposes.
7. All risk shall pass to the applicant once the applicant has taken delivery of the seedlings at the premises of Hishtil South Africa; alternatively in the event of Hishtil undertaking to deliver the seedlings to the applicant upon such delivery date and no responsibility can be accepted for any loss or damage which may occur to the seedlings after delivery thereof.
8. Although all seedlings are produced under the necessary Phyto-sanitary conditions and inspections, no undertaking can be given in this regard.
9. All possible care will be taken to ensure that the seedlings are true to name and type, but no guarantees, whether express or implied, are given in this regard.
10. The sale of the seedlings is voetstoots and no liability will attach to Hishtil for any loss or damage which may result directly or indirectly in respect of the condition of the seedlings or for any other reason whatsoever and Hishtil's liability will be limited to the costs of the seedlings only.
11. Should it become necessary to institute action against the applicant and to use the services of an attorney, the applicant accepts liability for costs on a scale as between attorney and client including collection commission and interest as set out above.
12. The applicant consents to the jurisdiction of the Magistrate's Court for the district of Letaba in respect of any claim arising from this agreement between the applicant and Hishtil in respect of the purchase of seedlings. However, nothing shall preclude Hishtil from instituting action in the High Court of South Africa (Transvaal Provincial Division), should Hishtil be so advised.
13. Hishtil will not be responsible for any damages suffered by the applicant due to Hishtil's failure to perform its obligations in terms of this agreement as a result of vis major, casus fortuitus or as a result of strikes, lock outs or any other cause beyond the control of the applicant.
14. The applicant chooses his domicilium citandi et executandi for all purposes at the address contained on page 1 of the application.
15. The applicant hereby grant permission that a credit check can be done before an individual/partnership/company/close corporation/trust will be approved as a client.
